Whereas the ARC and the Coach have come to an agreement, set out below, whereby the Coach will provide coaching services to the ARC and its members during the below mentioned season(s).

The Coach agrees to provide services as a volunteer rowing coach to the ARC for the following rowing program: _____ Start date _____ End date _____

Purpose of the Position

To deliver all aspects of the Coaching in _____ Program through working with a specified number of rowers.

To provide high quality coaching which meets the needs of both athletes, enabling them to realize their potential and aspirations, and the Argonaut RC goals.

Responsible to

Head Coach of Argonaut Rowing Club

General Responsibilities

- To liaise with the Head Coach to ensure that the athletes fully understand the aims and objectives of the Club in their program and its targets
- To be fully committed to the effective delivery of training sessions following the ARC annual and weekly training programs
- At all times present a positive image of Argonaut Rowing Club, its committees, volunteers and staff.
- To provide the Head Coach with an end of the year report of their program progress as well as monitoring and evaluation information in accordance with the agreed testing procedures at the club.

Specific Responsibilities

- On and off water coaching, and land training
- All crew related trailer loadings, unloading, and regattas
- Attendance at all coaches' meetings
- Communicate to the Head Coach in advance should the Coach be unable to supervise a practice or attend a regatta. Provide for alternate supervision in the event of the Coach's absence at a practice or regatta
- Ensuring boats are appropriately rigged for the use that is intended;
- Ensuring high quality of care and maintenance of all boat club assets, including coach boat and workshop materials and equipment;
- Communications with parents, including training programs, competitions, opportunities to support the Argonaut Rowing Club, training camps etc.

1. It is specifically acknowledged by the Coach that the Coach has read and understood the ARC's harassment and human rights policy, all other Club Policies, the Club Rules, and the ARC Code of Conduct and the Coach hereby agrees to act in accordance with those policies, rules and code.
2. The Coach agrees to provide proof of having a valid "Ontario Pleasure Craft License", a "Toronto Port Authority Operators' Permit", and have current First Aid and CPR certification as well as NCCP. The coach will receive a reimbursement for his expenses when any of the training seminars/course/workshops or conferences are approved by the Head Coach.
3. The Coach also acknowledges that the ARC, as a matter of compliance with requirements of due diligence, may carry out security checks with respect to the Coach, and the Coach hereby specifically consents to any security check the ARC may consider necessary or advisable, and will provide the necessary personal data to the ARC as required for the completion of a security check, and agrees that this document can be presented to confirm said consent.
4. The Coach shall comply with , and use his/her best efforts to ensure that those under his/her supervision comply with , all the Club Rules and regulations in effect from time to time (for example Code of Conduct, "Cold Water Rules"), as passed by the ARC, it's Club Rowing Captain, Head Coach, Board of Directors, and/or rowing committee, which may address conduct on ARC premises, usage of equipment, on or off ARC premises, the areas of the course to be used or to be considered off-limits to crews, coaches, coach boats, or any other matter.
5. The Coach agrees to pay full membership fees and competitive fees should they desire to race at any point during the "on water" season.
